We are therefore strongly committed to:



OBJECTIVES & TARGETS 2025

In line with MG VOWGAS Corporate IMS Policy and Integrated Management System-ISO 9001:2015 Quality Management System (QMS), ISO 14001: 2015 Environmental Management System (EMS), and ISO 45001: 2018 Occupational Health and Safety (OH&S) Management System, in consultation with MG VOWGAS workers, MGV Has established objectives and targets to achieve Zero OH&S incidents/negative environmental impacts, as well as quality products and services delivery, to enhance customer satisfaction.

We will ensure Quality, Health, Safety and Environmental deployment & compliance throughout the organization and our operations, in accordance with the Integrated Management System.

We commit to the following:

- Implement, Maintain and sustain the Integrated Management System and its certifications.
- Conduct Internal/Subcontractor Quality, OH&S and Environmental Audits at least once a year.
- Conduct Quality, Health, safety and Environment (QHSE) Management review at least ONCE a year.
- Conduct Management inspection/walkthrough, QHSE meetings on Monthly basis and Conduct Toolbox meetings daily.
- Setting and conducting OH&S, and Environmental activity plan as per schedule, workshop and Equipment inspection, Catering & hygiene inspection Quarterly.
- Maintain 100 percent Compliance with legal, OH&S, environmental and Quality requirements and regulations.
- 100% of our fabricated Pressure Vessels and every other product will be released without defect.
- Reduce Total Diesel consumption to achieve carbon footprint reduction by 5% annually.
- Reduce utility water usage by 5% from existing consumption of 480,000 liters/Month
- Waste generation including paper usage reduction from 20reams/month by 5 percent.
- The repair rate per linear length welded on RT/UT inspected joints will be less than 3% per project average and less than 4% per linear length welded by a welder or a welding operator.
- 100% compliance with the HSE Trainings and conduct HSE awareness and campaigns Quarterly and Behavioral based Safety (BBS) awareness meetings on weekly basis.
- 70% compliance with Quality, Technical and other training scheduled for the year.
- Review and Improve Emergency Preparedness response by conducting Emergency drills (Fire, Medical, Spill e.tc) quarterly
 and as project demand.
- Conduct 100% safety and environmental Risk Assessment including Job Hazard Analysis, on all MGV high and medium risk
 activities including project activities prior commencement.
- 100% of our inspection measurement and test equipment in use will be calibrated, including statutory regulatory requirements
 for all lifting equipment and accessories.
- . 100% Medical fitness checks and examination are conducted on personnel at least Yearly.
- Measure our level of customers' satisfaction via questionnaire/survey and achieve an average of above 70% score in 3 out of 4 customers measured yearly.

These Objectives shall be communicated to the entire workforce and reviewed periodically for the continual improvement of our IMS.
